

NOTICE OF PUBLIC HEARING

BY THE ORANGE COUNTY BOARD OF SUPERVISORS

SUBJECT: Board of Supervisors consideration of the Musick Jail Master Plan and certification of the proposed Supplement to Final Environmental Impact Report (Final EIR) No. 564 (SCH No. 96061024) for the James A. Musick Jail Expansion and Operation.

DESCRIPTION: The proposed project consists of revisions to the already approved expansion and operation of the Musick Jail. The previously approved project included an increase to a maximum of 7,584 inmates from the current population of approximately 1,250. The population of the 7,584 inmates represents a "worst case" scenario. The proposed expansion is anticipated to be phased over time with a variety of inmate population levels occurring over the project buildout. Related support structures will also be constructed. The project also includes booking and release of inmates, the construction of a warehouse, kitchen, laundry and central plant, and parking structures and surface lots. Finally, the Southeast Sheriff's Station and Interim Care facility are proposed to be located on the site.

LOCATION: The Musick Jail is located at 13502 Musick Drive on County unincorporated land abutting the Cities of Irvine and Lake Forest, in or near the third and fifth Supervisorial Districts.

APPLICANT: The County of Orange

ENVIRONMENTAL DOCUMENTATION: Proposed Supplement to Final Environmental Impact Report (Final EIR) No. 564 for Musick Jail.

PREVIOUS ACTIONS: On October 24, 2012 the Planning Commission voted 5 to 0 to recommend the Board of Supervisors approve and certify the Supplement to Final Environmental Impact Report No. 564 with the addition of the City of Irvine to the LF mitigation measures imposed to respond to concerns of the City of Lake Forest and approve the Musick Jail Master Plan.

Board of Supervisors approved the Musick Jail Master Plan and certified EIR No. 447 in November, 1986; Expansion of the facility and the associated environmental document, Final EIR No. 564, were approved and certified by the Board of Supervisors in 1996; Recirculated Sections of EIR 564 were approved and recertified in 1998.


