Review and consider the proposed Site Development Permits for the following: legalize modifications to a single-family dwelling and establishing two (2) caretakers' residences and a guesthouse (three units total); to legalize alternative setbacks; to allow the construction of a 174-square foot accessory gazebo; and to legalize grading in excess of 5,000 cubic yards. Use Permits are also requested for the following: legalize existing low intensity commercial outdoor recreation, wedding chapel, zoological garden, horticultural preserve and retreat/conference center uses; legalize existing over-height walls within the front yard setback; and legalize existing off-street parking modifications.
