

## **ORDER REGARDING TRANSFER OF FIREARMS**

TO: THE ORANGE COUNTY SHERIFF-CORONER and Specific Gun Dealer:

IT IS HEREBY ORDERED as follows:

1. The Orange County Sheriff-Coroner shall release to a duly authorized agent of (Specific Gun Dealer), upon presentation of documentation showing that he/she is the duly authorized agent of (Specific Gun Dealer), all firearm(s) seized from Defendant's Name on Date that can legally be possessed in the State of California [hereinafter "the firearms"]. The firearm(s) is/are currently being held for Crime/Safekeeping under Orange County Sheriff-Coroner Case # 00-00000.

2. The duly authorized agent of (Specific Gun Dealer) agrees to verify all serial numbers and commence with the necessary paperwork to transfer ownership to New Owner's Name, DOB 00-00-0000 of all firearm(s) seized from Defendant's Name on Date that can legally be possessed in the State of California.

3. No such preparations for transfer of the firearm(s) and no transfer of the firearm(s) shall occur until said duly authorized agent of Specific Gun Dealer has executed a Consent to Be Bound by this Order [hereinafter "the Consent"]. A form for the Consent is found at the end of this Order.

4. The Orange County Sheriff-Coroner or his designee shall cause to be filed in this action a copy of this Order on which the Consent has been executed by said duly authorized agent of Specific Gun Dealer.

5. The Orange County Sheriff-Coroner or his designee shall provide a copy of this Order to the person who executes the Consent.

6. Specific Gun Dealer shall not at any time return the firearm(s) to Defendant's Name.

7. Specific Gun Dealer shall not at any time sell or otherwise transfer the firearm(s) to a member of Defendant's Name household.

8. If it is discovered that New Owner's Name is not permitted, under any applicable law, to own, possess or use the firearm(s), or that New Owner's Name is a member of Defendant's Name household, this order shall be null and void, and the firearm(s) shall be returned to the possession of the Sheriff-Coroner for safekeeping. The weapon(s) would then be subject to lawful disposal pursuant to Title 10, Chapter 12, of the California Penal Code.

9. Specific Gun Dealer shall follow all applicable State and Federal

laws with respect to the firearm(s).

10. The Sheriff-Coroner shall cause to be destroyed, pursuant to applicable law, any weapon(s) seized from Defendant's Name on Date that may not legally be possessed in the State of California.
