Under investigation

The Sheriff declines to disclose to you at this time any of the record responsive to your request because the case is currently being investigated. We believe that releasing the record would compromise the pending investigation. Accordingly, we decline to disclose the record or any information extracted from the record pursuant to Government Code sections 6254(f), 6254(k) and Evidence Code section 1040 (official information privilege).

Case being reviewed by DA

The Sheriff declines to disclose to you at this time any of the record responsive to your request because the case is currently being reviewed by the District Attorney. We believe that releasing the record would compromise any criminal prosecution of this matter. Accordingly, we decline to disclose the record or any information extracted from the record pursuant to Government Code sections 6254(f), 6254(k) and Evidence Code section 1040 (official information privilege).

Request contemporaneous/investigatory

The Sheriff declines to disclose to you any of the record responsive to your request or any information extracted from the record because all the responsive record and information is exempt from public disclosure under the Public Records Act. The record itself is a law enforcement investigatory record that is categorically exempt from disclosure pursuant to Government Code section 6254(f). *Williams v. Superior Court*, 5 Cal. 4th 337 (1993). Government Code section 6254(f) (2) requires disclosure of selected information extracted from contemporaneous records of current police activities. *County of Los Angeles v. Superior Court*, 18 Cal. Request non-contemporaneous/investigatory

The Sheriff declines to disclose to you any of the record responsive to your request because all the responsive record is exempt from public disclosure under the Public Records Act. The record itself is a law enforcement investigatory record that is categorically exempt from disclosure pursuant to Government Code section 6254(f). *Williams v. Superior Court*, 5 Cal. 4th 337 (1993). Government Code section 6254(f) (2) requires disclosure of selected information extracted from contemporaneous records of current police activities. *County of Los Angeles v. Superior Court*, 18 Cal. App. 4th 588, 595-601 (1993). We do not consider this report to be a "contemporaneous record" since the date of occurrence is over 30 days ago.

Welfare and Institutions Code section 827/Juvenile Court Order

The Sheriff declines to disclose to you any of the record responsive to your request because the record involves juveniles and may not be released without approval from the Presiding Judge of the Juvenile Court. California Constitution, article I, section 1; Government Code sections 6254(k), 6255; Welfare and Institutions Code section 827 and Order of the Orange County Juvenile Court dated 1/28/97 "Policy: Confidentiality and Release of Information".
